ADVANCED DRIVER ASSISTANCE SYSTEMS (ADAS) MANDATORY SCANS

Today's Collision Repair Centers repairs vehicles in accordance with the available Original Equipment Manufacturers' (OEM) documented repair process specifications and procedures. If your vehicle is equipped with an ADAS, your vehicle manufacturer may require Today's Collision Repair Centers to perform both a PRE SCAN and POST SCAN of the system. The proper functioning of these safety and driver-assist systems could have been compromised as a result of a collision. ADAS is responsible for many of the safety and warning features including but not limited to blind spot sensors, lane departure systems, forward collision warning, automatic emergency braking and adaptive cruise control.

If required, you authorize us to perform both a pre-scan and post scan of the Advanced Driver-Assist and Safety features. The charge for the required scans is \$260 (\$130 per scan). Should your insurance carrier not compensate for this charge, it will be necessary for you to pay the fee for these OEM-mandated scans.

USE OF VEHICLE

Employees of Today's Collision Repair Centers and sublet vendors may operate your vehicle for the purpose of testing, delivery, sublet work, inspection by an insurer and/or a lien holder, or for other purposes reasonably related to repairs.

RATES / CHARGES / FEES

LABOR RATES - Today's Collision Repair Centers' labor rates may differ from those authorized by the insurance company, especially for advanced materials. Mechanical Repairs, Frame Repair, Specialty Work and/ or Specialty Paint may result in an additional out-of-pocket expense. You will be responsible for the costs of parts, labor, materials and/or sublet that are not covered by the insurance company. *Today's Collision Repair Centers' labor and material charges are posted at our facilities and are subject to change.*

FLAT RATE HOURS - Repair appraisals and the final repair bill will itemize repairs, including charges for parts and charges for hours of labor to perform repairs. Today's Collision Repair Center's labor charges are based on "flat rate" hours, which may not reflect actual hours worked, but rather estimated repair times based upon standard industry estimating guides.

STORAGE CHARGES – Unless otherwise scheduled, failure to pick-up your vehicle within 48 hours after you have been notified that repairs have been completed will result in storage fees at a rate of \$50.00 per day for outside storage and \$100.00 per day for inside storage. These rates will also apply should your vehicle be determined a "Total Loss."

PAYMENT

All charges for repairs must be paid when the vehicle is ready for delivery. We accept all major credit cards, Bank/Debit/Check cards, Insurance Checks, Personal Checks, Business Checks, Cashier Checks, Money Orders, Bank Checks, and Cash. An accepted <u>Direction to Pay</u> by the insurance company must be in place in order for Today's Collision Repair Centers to release your vehicle to you in the event that all payments from your insurance company have not been received prior to taking delivery of your vehicle. You will be responsible for your full deductible at the time of delivery.

Sometimes the insurance check, which is due to Today's Collision Repair Centers, will be mistakenly sent to the customer. In the event that you receive a check from the insurance company for the payment of your repair, you agree to contact Today's Collision Repair Centers and to deliver and endorse the check to us.
